PLEASE TAKE NOTICE that any qualified elector of Iron County who is not already registered, may register to vote at the office of the Township or City Clerk of the governmental unit where you reside; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at [mi.gov/vote](http://mi.gov/vote) and mailed to the local clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is Monday, October 19, 2020.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the office of the Township or City Clerk of the governmental unit where you reside on Election Day, Tuesday, November 3, 2020, from 7:00 a.m. to 8:00 p.m. and at the following times:
